DISCUSSION

David Burke-gave a brief recap of the budget process. It's a 2% tax rate increase.

Mayor Ecklond said the following:

I'd like to thank David Burke, Ryan Rueda and Jim LaPerche. They've spent countless hours on this budget.

This is the 15th budget I've worked on for the Village and there's one common theme in every one I've worked on regardless of how good or bad the economy is at the time and that is we always ask our Dept. Heads to find ways do more with less. And they always come through.

The Village has very dedicated employees and management who do a great job this and every year in making Tuckahoe an incredibly safe, clean and enjoyable community to live in. So many thanks to them all.

Deputy Mayor Giordano believes that 2% is an accomplishment. He thanked the Board and all the departments.

Trustee Luisi said the following:

Some may say this "it could be better" or "it could be worse." Albany mandates municipalities across the state operate at a 2% tax cap. In that regard this Board has met that obligation for better or for worse. More importantly in my estimation is that I believe this budget is best for the Village for its ability to allow day to day operations to continue at the current levels. This budget also plans for major capital improvement projects which are so vital to correcting and maintaining our current infrastructure. This budget before you is the result of hard work and numbers crunching by our Village Administrator David Burke and, our Treasury Department working side by side with our talented department heads to provide

this fiscally responsible budget. Improvements, training and updates with current technologies is factored into allowing all our departments to maintain pace with the needs of the modern world. We are ever mindful of maintaining of vehicular fleet to maximize their use and subsequent resale value. We also are mindful of providing sensible cost of living adjustments to our nonunion employees.

Our fund balance is at a healthy level and the financial overseers of municipal finances continue to compliment is stability and continued prosperous outlook.

This Board remains committed to exploring ways to improve the Village's financial outlook and ability to provide the so many reasons people want to live in Tuckahoe.

Trustee Andino thanked the board for answering her questions. Nonunion salaries have been compared to other municipalities. We crunched the numbers. We were responsible.

Trustee Lang said that there is a lot that goes into the budget process and is in favor of the budget.

Motion was seconded by Trustee Giordano and upon roll call was carried by a vote 5-0.
