Trustee Howell made a motion to approve minutes; motion was seconded by Trustee Lee and upon roll motion was carried by a vote 5-0.

RESOLUTIONS

- 1) Authorizing free short-term parking in the business districts of the Village to encourage local shopping during the holidays on all Saturdays of December and the week of December 21-26th Trustee Lee made a motion to approve resolution; motion was seconded by Trustee Howell and upon roll motion was carried by a vote 5-0.
