BOARD OF TRUSTEES MEMBER REPORTS

- ► TRUSTEE Andino gave library updates. The Police Reform survey is due Wednesday. Please have your voice heard. The survey is available on our website. We did Covid testing at the Community Center. We are trying to get vaccinations here. Trustee Andino touched on the events that occurred on January 6th. We need to meet the needs of the residents here.
- ▶ TRUSTEE Lang thanked the trustees for the Covid testing at the Community Center. He thanked the public for getting tested and urge all to get tested. Trustee Lang thanked the Beautification Association for their work. He asked all to complete the police survey.
- ▶ TRUSTEE Howell thanked everybody for their response for applying for Zoning. A lot of the items on Zoning and Planning are Marbledale Road. Trustee Howell echoed Trustee Andino regarding testing. Local officials are taking action. There are free flu shots at ECAP on January 13th. On February 3 Trustee Howell will be giving a zoom talk on the vaccine through the Tuckahoe Library. 50% of people who spread the disease have no symptoms. We need to be careful and wear masks. Trustee Howell gave a shout out to Adelaide DiGiorgi who is in the Westchester Citizens Hall of Fame. Trustee Howell commented on the events of January 6th calling it an act of domestic terrorism. We need to work and focus on fact and opinion and the difference of that. Trustee Howell invites all Tuckahoe and Eastchester board member to work together. Currently Trustee Howell is working on the zoning code regarding Historical structures in our village.
