Does the DEC and the DOH look at the viewpoint of what is built? They say "No." It is remediated for the zoning category. We are charged with making sure everything is done right.

He gave Kudos to David Burke commending his work on the financial status of the Village's fund balance, which is a testament to good number crunching by the department heads.
