DEPUTY MAYOR Giordano said we are having a zoning workshop to discuss zoning updates

TRUSTEE Leo gave library events for the month.

TRUSTEE Alfasi said that the Memorial Day celebration was wonderful and all should make an effort to attend next year.

Memorial Day Ceremony

The Mayor thanked Trustee Steve Alfasi who represented the Village at the Veterans Memorial Day Ceremony at the High School. He mentioned Steve is a veteran, former Captain with the US Air Force.

Triangle Park Parking

The Mayor reported that the Police Dept. sent out a survey soliciting opinion on whether we should add 3 parking spaces along the East side of Triangle Park. The results came back The NO's were 18 The YES's were 9 The Mayor suggested we keep it as for now.

TCE-COUNTY-DOH Update

The Mayor reported that this morning the Marbledale Road Environmental Coalition sent out an email blast with some questions regarding the Ecosystems report for testing that was reported in this week's Review Press Newspaper. For the record, reporter Corey Stockton called and he apologized for mistakenly NOT reporting that this story was about the tests that were done 3 to 4 months ago, one on FEB 16th and the other Mar 3rd. He put a correction in the coming week's paper. Anyway, the Coalition has asked the following:

Who is in charge of finding the source of the TCE in the air? ANSWER

The Westchester County Department of Health, Air Quality Division 145 Hugenot St., New Rochelle, NY

Ms. Natasha Court #914-813-5000

Why is it taking so long to find the source? ANSWER

The Village asks the same question.

The Village's environmental vendor (HDR) has a foil request out to them for copies of all Air Discharge Information related to locations in Tuckahoe

Is the county moving slow to protect the developer? ANSWER

My answer is - I doubt it.

But anyone from the public can call the County and ask for themselves.

Who is leading the charge to protect the residents? ANSWER

The Westchester County Department of Health, Air Quality Division is responsible for all Air Quality Investigations for locations in Westchester County. This service is provided and paid for by all Westchester County residents through their County Property Tax Bill.

The Ecosystems test report is in the hands of the AirQuality Division of the County DOH

The Village has received a few new paint spray booth smell complaints which we have brought to the attention of the County Air Quality Dept. which we will be asking them to report on David-do you want to elaborate on some of these calls?

Marbledale Road Construction Update

The Mayor reported that as our residents can see the project on Marbledale Road has moved into the Construction Phase for the Restaurant and Hotel. What I'll do on a monthly basis is report on a timeline of what's going on

First I want to report that I have been holding monthly meetings with the Contractor, his environmental team, the Village's Environmental team and the Village Bldg Dpt. To review the status and the look ahead.

The last of these meetings was this past Thursday.

Here's some highlights:

- 1. RIC Rapid impact compaction: The developer will be doing this only between 8am-5:30pm RIC work will be done this Friday (possibly next mon or Tue if rain is a problem this week)
- 2. Street Opening Work: There's one week left and they will be starting to install sidewalks down towards Westys to the end of their property line
- 3. Micro-Pile drilling: 25% of this work is done. Anticipated completion is Early August since they just brought onsite a second drill rig.
- 4. There is still an HDR or DEC representative onsite every day they are working.
- 5. Next BCP Community Meeting is Wed. June 28th

It should be noted: Micro-Pile is a closed-loop system – all water remains onsite.

SWIP program manages all water. No water leaves the site.

Long term:

July The site grading and leveling should wrap-up and the land will be "capped" with gravel in some areas, concrete in some areas and blacktop binder in others

Landscape areas will be installed (no plantings yet)

Fencing will come down and the perimeter of the construction zone – the hotel will be fenced in.

August Micro-Piles are done.

Structural steel will start to go up

Status of the Article 78 Lawsuit Preliminary Injunction

The Mayor reported that on May 26th Judge Larry Schwartz rendered his decision on this issue To refresh the memory of the public

There are 9 members of our community who filed a lawsuit against the Village, The NYS DEC & DOH in regards to the Marbledale Road Hotel Project and BCP Site.

The Village Attorney explained what the decision was and what it means

Village attorney Gary Gjertsen explained that the lawsuit to stop the project immediately was denied by Judge Larry Schwartz.

The Board wanted the public to be aware that this lawsuit has cost the taxpayers \$200,000.

SECOND OPPORTUNITY TO ADDRESS THE BOARD

Residents from Eastchester, Tuckahoe and Yonkers voiced their concerns are the procedures being followed to clean up the Marbledale Road site. Mr. Minnich submitted 4 summa canister sampling charts from Minnich and Scotto.
