2. Public hearing -LOCAL LAW NO. 2 OF 2014

A LOCAL LAW REPEALING SECTION 2-12 OF THE VILLAGE CODE OF THE VILLAGE OF TUCKAHOE, ENTITLED "RESIDENCY OF OFFICERS, EMPLOYEES" AND RESTATING AND RE-ENACTING RESIDENCY REQUIREMENTS APPLICABLE TO CERTAIN POSITIONS WITHIN THE VILLAGE OF TUCKAHOE

At a regular meeting of the Village Board of the Village of Tuckahoe, New York (the "Village Board") held at Village Hall, 65 Main Street, Tuckahoe, New York on April 14, 2014.

WHEREAS, a resolution was duly adopted by the Village Board of Trustees of

the Village of Tuckahoe, New York for a public hearing to held by the Village Board on

the 14th day of April 2014 at 8:00 p.m. at Village Hall, 65 Main Street, Tuckahoe, New

York, to hear all interested parties concerning the repeal of Section 2-12 of the Village

Code of the Village of Tuckahoe, entitled "Residency of Officers, Employees" and the

enactment of Local Law No. 2 of 2014 which shall repeal Section 2-12 of the Village

Code of the Village of Tuckahoe and restate residency requirements applicable to

certain positions with the Village of Tuckahoe; and

WHEREAS, notice of said public hearing was duly advertised in the Journal News, the official newspaper of said Village, on the 15th day of March 2014; and

WHEREAS, said public hearing was duly held on the 14th day of April 2014 at 8:00 p.m. at Village Hall, 65 Main Street, Tuckahoe, New York, and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to the

repeal of Section 2-12 of the Village Code of the Village of Tuckahoe, entitled "Residency of Officers, Employees" and the enactment of Local Law No. 2 of 2014 which shall repeal Section 2-12 of the Village Code of the Village of Tuckahoe and further restate residency requirements applicable to certain positions within the Village of Tuckahoe; and

WHEREAS, the Village Board, after due deliberation, finds it in the best interest of said Village to adopt said Local Law.

Be it enacted by the Village Board of Trustees of the Village of Tuckahoe as follows:

Section 1. Section 2-12 of the Village Code of the Village of Tuckahoe, entitled "Residency of Officers, Employees", inclusive of sub-sections (a) through (f), is hereby repealed in its entirety.

Section 2. Section 2-12 of the Village Code of the Village of Tuckahoe, as amended, shall be entitled "Residency Requirements."

Section 3. Section 2-12 of the Village Code of the Village of Tuckahoe, as amended, entitled "Residency Requirements" shall be restated and re-enacted as follows:

Section 2-12 Residency Requirements.

(a) Purpose; Legislative Authority.

<u>The Village Board of Trustees finds that, due to the relatively small population</u> <u>of the Village of Tuckahoe, it is not always possible to fill certain appointive</u> <u>offices, employment positions and/or nonjudicial positions in Village</u> <u>government requiring municipal, administrative or financial expertise with</u> <u>Village of Tuckahoe or Town of Eastchester residents who are duly qualified</u> to hold such positions. The Village Board of Trustees further finds that it is authorized to appoint qualified residents of Westchester County outside of the Village of Tuckahoe and Town of Eastchester to said offices pursuant to § 3-300 of the New York State Village Law as well as further appoint qualified residents of Westchester County to certain positions of employment. The Village Board of Trustees further finds that it is authorized under § 3-300 of the New York State Village Law and § 10 of the New York State Municipal Home Rule Law to expand such residency requirements to allow residents of Westchester County to be eligible for appointment to said offices as well as further allow for residents of Westchester County to be eligible to hold certain positions of employment.

(b) Definition.

"Residence" is defined in this Local Law and section to mean the abode or place where one actually lives and maintains a fixed, permanent and principal home.

(c) Residency within the County of Westchester required.

Notwithstanding any other general or special law, no person shall be eligible to be appointed to or hold office of the Village Clerk, Deputy Village Clerk, Village Treasurer, Deputy Treasurer, Village Assessor, Deputy Assessor, Building Inspector/Facilities Manager, Code Enforcement Officer, Village Court Clerk or Assistant Court Clerk who is not a citizen of the United States, is not at least 18 years of age and is not a resident of Westchester County, New York. No person shall be eligible to hold the position of employment as <u>Village Attorney or Deputy Village Attorney who is not a citizen of the United</u> <u>States, is not at least 18 years of age and is not a resident of Westchester</u> <u>County, New York. No person shall be eligible to be appointed as an election</u> <u>inspector in the Village of Tuckahoe unless such person is a resident of</u> <u>Westchester County, New York.</u>

- (d) This section shall change and supersede § 3-300, Subdivision 2, of the New York State Village Law, as last amended, § 3 of the New York State Public Officers Law, as last amended, and § 23 of the New York State Town Law, as last amended, to the extent that the provisions thereof conflict with or are contrary to the provisions of this Local Law. The provisions of the Local Law shall govern and control in the event of conflict.
- (e) Insofar as the provisions of this Local Law are inconsistent with the provisions of any other Village of Tuckahoe local law or resolution and/or the terms or provisions set forth in the Village Code of the Village of Tuckahoe, the provisions of this Local Law shall be controlling and shall govern.
- (f) If any section of this Local Law shall be held unconstitutional, invalid, or ineffective, in whole or in part, such determination shall not be deemed to affect, impair, or invalidate the remainder of this Local Law.
- (g) This Local Law shall take effect immediately upon filing with the Secretary of State of the State of New York and shall apply to all persons currently holding the positions of Village Clerk, Deputy Village Clerk, Village Treasurer, Deputy Treasurer, Village Assessor, Deputy Assessor, Building Inspector/Facilities Manager, Code Enforcement Officer, Village Court Clerk, Assistant Court

Clerk, Village Attorney and Deputy Village Attorney as well as any persons

hereafter appointed to fill such offices or such positions of employment.

Section 4. The Village Clerk be and she hereby is directed to enter this Local

Law in the minutes of this meeting and give due notice of the adoption of said Local Law

to the Secretary of the State of New York.

A RESOLUTION SCHEDULING A PUBLIC HEARING ON REPEALING LOCAL LAW NO. 1 OF 2014 ENTITLED, "A LOCAL LAW AUTHORIZING A PROPERTY TAX LEVY IN EXCESS OF THE LIMIT ESTABLISHED IN GENERAL MUNICIPAL LAW SECTION 3-C," SUCH LOCAL LAW NO. 1 OF 2014 HAVING BEEN ENACTED ON FEBRUARY 10, 2014

At a regular meeting of the Village Board of Trustees of the Village of Tuckahoe, New York (the "Village Board") held at Village Hall, 65 Main Street, Tuckahoe, New York on April 14, 2014.

WHEREAS, it was requested that the Village Attorney draft a local law

authorizing the Village Board to adopt a budget for the fiscal year commencing June 1,

2014 that requires a real property tax levy in excess of the amount otherwise prescribed

in General Municipal Law Section 3-c; and

WHEREAS, the Board of Trustees conducted a public hearing relating to a local

law authorizing the Village Board to adopt a budget for the fiscal year commencing June

1, 2014 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law Section 3-c; and

WHEREAS, on February 10, 2014, the Village Board enacted Local Law No. 1 of 2014 entitled, "A Local Law Authorizing A Property Tax Levy In Excess Of The Limit Established In General Municipal Law Section 3-C;" and

WHEREAS, the Village Board is considering repealing Local Law No. 1 of 2014 in its entirety.

NOW, THEREFORE, BE IT RESOLVED

Section 1. That in accordance with the provisions of the Municipal Home Rule Law and other applicable law, a public hearing shall be held on the 12th day of May 2014 at 8:00 o'clock p.m., at Village Hall, 65 Main Street, Tuckahoe, New York, at which hearing parties in interest and citizens shall have an opportunity to be heard and at which time and place it shall be determined by the said Board of Trustees whether Local Law No. 1 of 2014 entitled, "A Local Law Authorizing A Property Tax Levy In Excess Of The Limit Established In General Municipal Law Section 3-C," such Local Law No. 1 of 2014 having been enacted on February 10, 2014, shall be repealed in its entirety.

Section 2. That the notice of the time and place of such public hearing shall be published by the Village Clerk in the manner provided by applicable law and the Village Board directs that all requisite notices be published in accordance with applicable law.

Section 3. That this resolution shall take effect immediately.

Trustee Alfasi asked John Cavallaro to explain this resolution repealing the tax cap levy. John Cavallaro gave a brief explanation of the repeal.

Trustee Luisi made a motion to adopt resolution #7; motion was seconded by Trustee Quigley and upon roll call, motion was carried by a vote of 5-0.

WHEREAS, the Village Board is considering a rezoning petition for a portion of

Lake Avenue properties and surrounding properties (the premises commonly known as

150 Lake Avenue- section 33 block 7 lot 4, 8 Cedar Street- section 33 block 7 lot 2, and

10 Cedar Street-section 33 block 7 lot 1) from an Industrial Zoning District to a

Residential B Zoning District; and

WHEREAS, in connection with such rezoning, the Village Board is also

considering amending the Village Comprehensive Plan in connection with such rezoning petition; and

WHEREAS, the Village Planning Consultant has recommended that the Village Board of Trustees declare its intent to act as lead agency for purposes of SEQRA for the actions described herein;

NOW, THEREFORE, BE IT RESOLVED

Section 1. Based on the information included in the Environmental Assessment Form and/or the criteria contained in 6 NYCRR § 617.7, the Village Board hereby declares its intent to act as Lead Agency for SEQRA review of the proposed actions, and copies of the SEQRA material will be provided to the Involved and Interested Agencies and the public during the review of whether to amend the Village Comprehensive Plan for such rezoning petition and rezone a portion of Lake Avenue properties and surrounding properties (the premises commonly known as 150 Lake Avenue- section 33 block 7 lot 4, 8 Cedar Street- section 33 block 7 lot 2, and 10 Cedar Street-section 33 block 7 lot 1) from an Industrial Zoning District to a Residential B Zoning District.

Section 2. This resolution shall take effect immediately.

RESOLUTION #10

A RESOLUTION SCHEDULING A PUBLIC HEARING ON AN AMENDMENT TO THE VILLAGE OF TUCKAHOE COMPREHENSIVE PLAN, DATED MAY 2008

At a regular meeting of the Village Board of the Village of Tuckahoe, New York (the "Village Board") held at Village Hall, 65 Main Street, Tuckahoe, New York on April 14, 2014

WHEREAS, the Village Comprehensive Plan, adopted May 2008, contains certain zoning recommendations, including, but not limited to, rezoning recommendations for the Lake Avenue Industrial Area; and

WHEREAS, the Village Comprehensive Plan provides that:

Lake Avenue Industrial Area (Rezoning)

This small industrial area is located between the Metro-North railroad tracks and Lake Avenue just north of Main Street (see Figure 9-1: Existing Industrial Areas – Area 2). Much of the area actually serves as commuter parking for the Tuckahoe Station. It is suggested that this area would be more appropriate as a business zone; (see page 45);

and

WHEREAS, the Mayor and Board of Trustees seek to conduct a public hearing relating to a Comprehensive Plan amendment that would amend the Comprehensive Plan as follows:

Lake Avenue Industrial Area (Rezoning) This small industrial area is located between the Metro-North railroad tracks and Lake Avenue just north of Main Street (see Figure 9-1: Existing Industrial Areas – Area 2). Much of the area actually serves as commuter parking for the Tuckahoe Station. [It is suggested that this area would be more appropriate as a business zone] <u>It is suggested that the south</u> side of Cedar Street be excluded from this industrial zone. There are three parcels along Cedar Street that should be zoned residential so that current residential homes are protected and both side of Cedar Street are residential. These parcels related to the Res. B district to the north and could, therefore be zoned Residential B.

NOW, THEREFORE, BE IT RESOLVED

Section 1. That in accordance with the provisions of Village Law § 7-706 et seq. and other applicable law, a public hearing shall be held on or about the 12th day of May 2014, at 8:00 o'clock p.m., at Village Hall, 65 Main Street, Tuckahoe, New York, at which hearing parties in interest and citizens shall have an opportunity to be heard and at which time and place it shall be determined by the said Mayor and Board of Trustees whether the Village Comprehensive Plan, adopted May 2008, shall be amended as aforestated herein.

Section 2. That the notice of the time and place of such public hearing shall be published by the Village Clerk in advance of such time and place in the manner

provided by law.

Section 3. That this resolution shall take effect immediately.
