## PROPOSED LOCAL LAW #1 OF 2015

# A LOCAL LAW AUTHORIZING A PROPERTY TAX LEVY IN EXCESS OF THE LIMIT ESTABLISHED IN GENERAL MUNICIPAL LAW SECTION 3-C

At a regular meeting of the Village Board of Trustees of the Village of Tuckahoe, New York (the "Board") held at Village Hall, 65 Main Street, Tuckahoe, New York on February 9, 2015.

WHEREAS, legislation has been requested authorizing the Board to adopt a budget for the fiscal year commencing June 1, 2015 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law Section 3-c,

Be it enacted by the Village Board of Trustees of the Village of Tuckahoe as follows:

# Section 1. Legislative Intent

It is the intent of this Local Law to allow the Village of Tuckahoe to adopt a budget for the fiscal year commencing June 1, 2015 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law Section 3-c.

## Section 2. Authority

This Local Law is adopted pursuant to subdivision 5 of General Municipal Law Section 3-c, which expressly authorizes a local government's governing body to override the property tax cap for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of said governing body.

## Section 3. Tax Levy Limit Override

The Board of Trustees of the Village of Tuckahoe, County of Westchester, is hereby authorized to adopt a budget for the fiscal year commencing 2015 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law Section 3-c.

## Section 4. Severability

If a court determines that any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this Local Law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual,

firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

## Section 5. Effective Date

This Local Law shall take effect immediately upon filing with the Secretary

Trustee Giordano made a motion to open public hearing #1; motion was seconded by Trustee Luisi and upon roll call, motion was carried by a vote of 5-0.

Mayor Ecklond explained this law would allow the Village to override the tax cap should the need arise when in the best interest of the community.

Trustee Quigley made a motion to close public hearing #1; motion was seconded by Trustee Giordano and upon roll call, motion was carried by a vote of 5-0.

#### ADOPTION OF MINUTES

Trustee Alfasi made a motion to approve the minutes of the regular meeting of January 12, 2015; motion was seconded by Trustee Giordano and upon roll call, motion was carried by a vote 5-0.

## FIRST OPPORTUNITY TO ADDRESS THE BOARD ON AGENDA ITEMS

Anthony Fiore questioned why the Home Rule resolution is on the agenda again. David Burke explained it must be done annually.

**RESOLUTION #1** adopting Local Law #1 of 2015 authorizing a property tax levy in excess of the limit established in General Municipal Law section 3-C. Trustee Quigley made a motion to adopt resolution #1; motion was seconded by Trustee Giordano and upon roll call, motion was carried by a vote of 5-0.

**RESOLUTION #2** authorizing the appointment of Assistant Court Clerk, Barbara Sarmient. Trustee Luisi made a motion to adopt resolution #2; motion was seconded by Trustee Giordano and upon roll call, motion was carried by a vote of 5-0.

Mayor Ecklond said that Pat Janniello has retired. David Burke added that after Judges Fuller and O'Toole and Court Clerk, Maureen Stevens had interviewed two great candidates, Barbara Sarmiento was chosen.

**RESOLUTION #3** authorizing a Home Rule Request to the NYS Legislature in support of a Village of Tuckahoe Hotel/Motel Occupancy Tax

# A HOME RULE MESSAGE IN SUPPORT OF A VILLAGE OF TUCKAHOE HOTEL/MOTEL OCCUPANCY TAX

At a meeting of the Village Board of Trustees of the Village of Tuckahoe, New York (the "Village Board") held at Village Hall, 65 Main Street, Tuckahoe, New York on February 9, 2015.

WHEREAS, the Village Board supports the concept of the adoption of State legislation to impose a room "occupancy tax" on persons occupying any hotel or motel for hire in the Village; and

WHEREAS, the Village of Tuckahoe is supportive of the adoption of Hotel Occupancy Tax legislation authorizing the Village of Tuckahoe to adopt a local law to impose a hotel/motel occupancy tax for hotels and motels located in the Village of Tuckahoe; and

WHEREAS, since the Village of Tuckahoe does not have the authority to enact such legislation by local law, the Village of Tuckahoe must request that the State act on the matter through the adoption of a Home Rule Request; and

WHEREAS, the Home Rule Request from the Village of Tuckahoe shall state in the portion of the document marked "Explanation" the following:

During these difficult economic times, municipalities need additional non-property tax sources of revenue to fund basic services to keep their communities safe and properly serviced. This legislation will assist the Village of Tuckahoe to fund necessary services.

## NOW THEREFORE, BE IT RESOLVED

Section 1. That the Village Board does hereby adopt a Home Rule Request asking the State Legislature to adopt an Assembly Bill and Senate Bill authorizing the Village of Tuckahoe to adopt a local law to impose a hotel/motel occupancy tax for hotels and motels located in the Village of Tuckahoe.

Section 2. That this Home Rule Message/Request shall take effect immediately.

Trustee Quigley made a motion to adopt resolution #3; motion was seconded by Trustee Giordano and upon roll call, motion was carried by a vote of 5-0.

David Burke explained that it must be done annually. It is an alternate source of revenue.

**RESOLUTION #4** authorizing the intent to join Westchester County in their submission of a consolidated Government Efficiency Plan. Trustee Giordano made a motion to adopt resolution #4; motion was seconded by Trustee Luisi and upon roll call, motion was carried by a vote of 5-0. This is the government tax freeze program. It is mandated that the submission be made by 6/1/15 to receive the rebates that you have been receiving.

**RESOLUTION #5** authorizing the adoption of the Village of Tuckahoe Workplace Safety and Loss Prevention Program. Trustee Quigley made a motion to adopt resolution #5; motion was seconded by Trustee Giordano and upon roll call, motion was carried by a vote of 5-0. David Burke said that this manual puts operational in place and hopefully reduce accidents.

RESOLUTION #9 authorizing the issuance of a Special Cabaret Permit to Broken Bow Brewery for a Kolsch Fest, with live music, on February 21, 2015 from 3:00 p.m. to 11:00. p.m. Trustee Luisi made a motion to adopt resolution #9; motion was seconded by Trustee Quigley and upon roll call, motion was carried by a vote of 5-0.

**RESOLUTION #10** authorizing the approval of vouchers in the amount of \$413,728.73. Trustee Giordano made a motion to adopt resolution #10; motion was seconded by Trustee Alfasi and upon roll call, motion was carried by a vote of 5-0.

The Tuckahoe Coverlet is \$40.00 and available for purchase at the Clerk's Office or Community Center.
- ► TRUSTEE Alfasi asked that residents to come out to the budget hearing to look at village budget as well as to look at the state budget. One of the largest portions of the state budget goes to the schools.
- ► MAYOR Ecklond reported the Crestwood Project is quickly coming together. The Con Ed project on Lincoln is independent from the Crestwood Project. Last week, the Administrator, the treasurer and I attended a webinar. We should have 5% to10% in our fund balance. Our snap shot was taken on May 31, 2014 which does not give a true fiscal picture.
