So many people lost all of their property that was stored in the buildings basements, but even worse they lost their cars also. after speaking to a FEMA representative, I was informed that any resident who suffered lost property, had damage to their homes caused by hurricane ida, can file a claim with FEMA, once you have your insurance company come in and assess the damages and gives you a written estimate on your losses and lets you know what they will not cover. You can then file a claim with FEMA for the things that was not covered by your insurance company. This includes your cars. You need to have your car looked at by a mechanic shop and have a written estimate on what damages was caused by the flooding and you can file a claim through FEMA who will then submit your claim to the state of NY. For assistance through FEMA, you can go to their website which is www.fema.gov/assistance. 911-to all of the families of the victims and first responders that was lost on and since 9-11-2001. May God continue to keep, bless and strengthen you as continue to cope with the pain of losing those who remain dear to your heart
