**Item #1 Approval of Minutes May 17, 2021**

**Chairwoman Raffiani motioned to approve the minutes of the May 17, 2021 meeting. This motion was seconded by Member Nieminen and was carried by the Board with a vote of 2-0.**

**Item #2 24 Columbus Avenue New Sign**

Christine Fitzgibbons and Lesley Myers business owners of “Bargello Needlepoint” presented an application for an arm sign. The arm sign measures 18 by 19.5 inches. The letter size for “bargello” is 3 inches and “needlepoint” is .5 inches. The color of the letters is purple. The color of the logo is orange and purple with a white background. There were discussion regarding the height of the arm sign from grade. It was noted that the sign is 84 inches from grade.

**Chairwoman Raffiani made a motion to approve the application as presented for “Bargello Needlepoint”. This motion was seconded by Member Nieminen and was unanimously carried by the board with a vote of 2-0.**

**Item #3 88A Main Street New Sign**

Ciara Calise business owner of “BeYOUTiful Lashes” presented an application for a window sign. The letter size for “BEYOUTIFUL LASHES” is 5 inches. The letters will be white vinyl adhesive. There was discussion regarding the font used for the letters. The LLC is “BeYOUTiful” however the logo is all capital letters. Chairwoman Raffiani suggested that it would be more effective visually if the letters are upper and lower case letters. Ms. Calise said that she would like to keep the letters all upper case.

**Member Nieminen made a motion to approve the application as presented for “BEYOUTIFUL LASHES” with a variance for the letter size exceeding the maximum allowed by code. This motion was seconded by Chairwoman Raffiani and was unanimously carried by the board with a vote of 2-0.**
