**Item #1   Approval of Minutes January 22, 2013**  
**Member Pushkal motioned to approve the minutes of the January 22, 2013 meeting. This motion was seconded by Chairwoman Ciaramella and unanimously carried by the Board with a vote of 2-0.**

**Chairwoman Ciaramella explained to the applicant that one member was absent and in order to get the awning approved, he would need a unanimous vote. Chairwoman Ciaramella advised the applicant that he had the option to postpone to the next meeting or continue today. The applicant agreed to continue today.**

**Item #2           70 Main Street           New Awning**

Mr. Paul Mazzacane, of Gregory Sahagian & Son, Inc. representing “Salon 70” presented an application for recovering existing awning. The material is Sunbrella standard fabric. They will have the material treated for Fire Retardant. The reason for the standard fabric is because the color red is a different shade then the Fire Retardant material. Chairwoman Ciaramella advised them that they need to

provide the Building Department the certificate that the material was treated prior to installing the awning. Chairwoman Ciaramella asked if the red presented is the same color as the awning next door. Mr. Mazzacane was unsure however, Member Pushkal was sure that it was the same color red. Each logo "Salon 70" is 6 inches high and 40 inches wide. Member Pushkal suggested removing the "70" on either side of the logo and leaving the "Salon 70" in the center. Mr. Mazzacane asked if they could change the font that was presented to the font he brought at the meeting. The new font has a stencil look that makes the letter look nicer. There is a red line that goes through the letters.

Chairwoman Ciaramella read an email from Member Nieminen regarding changing the font size to 5 inches. There was discussion regarding the size, however, the applicant was not in favor of changing the size.

**Chairwoman Ciaramella made a motion to approve the awning for "Salon 70". The approved awning will have "Salon" on either side of the awning with "Salon 70" in the center. They will be white letters with an accented red line through the letters. The letters will all be 6 inches high. A Fire Retardant certificate will be submitted to the Building Department prior to installing the awning. The black lines on the awning will be removed. Member Pushkal seconded the motion and it was unanimously carried by the board with a 2-0 vote.**

The next meeting will be held on Tuesday, March 19, 2013 at 2:30pm

There being no further comments from the public or business before the Board, upon motion duly made, seconded and unanimously carried, the meeting was adjourned at 2:45 pm.
