## Item #1 Approval of Minutes June 14, 2012

Member Nieminen motioned to approve the minutes of the June 14, 2012 meeting. This motion was seconded by Member Pushkal and unanimously carried by the Board with a vote of 2-0.

## Item #2 109 Lake Avenue New Awning

Mr. John Cappabianca of San Signs, representing "Rua Salon" presented an application for two awnings. The first awning is 10 feet 9 inches by 36 inches in a Burgundy Sunbrella color. The color of the letters is Ivory Copy with the "R" being 8 inches in height and the "ua" being 6 inches in height. Also on the awning is the word "SALON" in 5 inch letters located at the bottom right hand side of the awning. The second awning is 5 feet 7 inches by 36 inches in the Burgundy Sunbrella color placed over the entrance of the door. This awning has the number "109" in Ivory Copy with 5 inches letters located at the bottom right hand side of the awning. Both awnings will have an "L" shape border in the Ivory Copy color. These awnings are also Fire resistant.

## Item #3 115 Main Street New Sign
