ADMINISTRATION OF OATH OF OFFICE

Swearing in of Greg Luisi as Village Trustee for a 2 year term by Mayor Steven A. Ecklond

6) Proclaiming APRIL 28, 2017 as "ARBOR DAY" in the Village of Tuckahoe

WHEREAS: TREES reduce the erosion of our precious topsoil by wind and water, cut heat and cooling costs, moderate the temperature, clean the air, produce oxygen and provide habitat for wildlife; and

WHEREAS: TREES are a renewable resource giving us paper, wood for our homes, fuel for our fires and countless other wood products; and

WHEREAS: TREES in our Village increase property values, enhance the economic vitality of business areas, and beautify our community; and

WHEREAS: TREES, wherever they are planted, are a source of joy and spiritual renewal; and

WHEREAS: the Village of Tuckahoe has been recognized as a Tree City USA by the National Arbor Day Foundation and desires to continue its tree-planting practices.

NOW, THEREFORE, I, Steven A. Ecklond, Mayor of the Village of Tuckahoe, on behalf of the Board of Trustees and all of the residents of Tuckahoe, do hereby proclaim APRIL 28, 2017 as "ARBOR DAY" in the Village of Tuckahoe, and urge all Citizens to celebrate Arbor Day and to support efforts to protect our trees and woodland; and

FURTHER, I urge all citizens to plant trees to gladden the heart and promote the wellbeing of this and future generations.
