ADOPTION OF MINUTES

Trustee Leo made a motion to approve the minutes of the regular board meeting of September 21, 2015; motion was seconded by Trustee Alfasi and upon roll call, motion was carried by a vote 3-0. Trustee Luisi abstained.

FIRST OPPORTUNITY TO ADDRESS THE BOARD ON AGENDA ITEMS

RESOLUTIONS

1) **BE IT RESOLVED THAT**, according to Section 15-104, sub. 3(a) of the New York State Election Law, there shall be nominated two nominees for the office of Trustee, said office to be held for a term of two years, beginning April 1, 2016

BE IT FURTHER RESOLVED THAT Elections for such office shall be held on the 15th day of March, 2016 in the seven Election Districts (10, 11, 12, 13, 14, 32, 33) within the Village of Tuckahoe Trustee Leo made a motion to approve resolution 1; motion was seconded by Trustee Luisi and upon roll call, motion was carried by a vote 4-0.

2) Trustee Luisi made a motion authorizing the sale for a bid in the amount of \$8,700 for a 2001 Dodge 1-ton dump truck auctioned on eBay; motion was seconded by Trustee Leo and upon roll call, motion was carried by a vote 4-0.

- 3) Trustee Leo made a motion authorizing the sale for a bid in the amount of \$187.49 for a rand model UC-200 air compressor auctioned on eBay; motion was seconded by Trustee Alfasi and upon roll call, motion was carried by a vote 4-0.
- 4) Trustee Leo made a motion Authorizing the sale for a bid in the amount of \$100 for leer truck cap auctioned on eBay; motion was seconded by Trustee Alfasi and upon roll call, motion was carried by a vote 4-0.
- 5)Trustee Luisi made a motion Declaring a 2012 Dodge Charger with police package and a blue Kestrel 200 Sci racing bicycle as surplus for sale on eBay; motion was seconded by Trustee Leo and upon roll call, motion was carried by a vote 4-0.
- 6)Trustee Leo made a motion Authorizing the closure of Warren Avenue for a Halloween party and parade organized by the Westchester Park Civic Association on Saturday, October 31, 2015 (time to be determined); parade route commencing at Marbledale Road at Lincoln Avenue to Stewart Avenue to Warren Avenue; motion was seconded by Trustee Alfasi and upon roll call, motion was carried by a vote 4-0.
- 7)Trustee Luisi made a motion Authorizing the approval of vouchers in the amount of \$412,265.01 consisting of Abstract #13 for \$224,359.66, Abstract #14 for \$3,624.42, and Abstract #15 for \$184,611.88. The three largest invoices paid were: (1) \$PCI Industries Corp. for \$89,572.45, (2) \$50,506.25 for Travelers Insurance (3) \$50,000 for New York State Insurance Fund; motion was seconded by Trustee Leo and upon roll call, motion was carried by a vote 4-0.
