- 3) IF YOU ARE A NEW HOMEOWNER — A COPY OF YOUR DEED IS REQUIRED

**NON- PROPERTY OWNERS (RENTERS)**

- 1) VALID REGISTRATION- PER CAR WITH CURRENT TUCKAHOE ADDRESS
- 2) VALID LEASE
- 3) CON EDISON BILL- FOR CURRENT ADDRESS IN YOUR NAME  
(no utility needed for renewals)

**CO-OP OWNERS MUST ALSO PROVIDE A COPY OF THEIR SHARES**
