## **ELECTRIC SCOOTER**

### DEFINITION:

1. HAS FLOORBOARD OR SEAT WITH ELECTRIC MOTOR THAT CAN BE POWERED BY ELECTRIC MOTOR AND/OR HUMAN POWER
2. WEIGHS LESS THAN 100 POUNDS
3. HAS A MAXIMUM SPEED OF 20 MPH ON A PAVED LEVEL SURFACE

### TYPICAL EXAMPLE:



MUST FOLLOW ALL VEHICLE & TRAFFIC LAWS FOR BICYCLES (1231) & MOTOR VEHICLES IN ADDITION TO THE FOLLOWING VEHICLE & TRAFFIC LAWS PERTAINING SPECIFICALLY TO SCOOTERS:

- 12811 CARRY MORE THAN ONE PERSON / RIDE WHILE CARRYING CHILD
- 12822 CARRY PACKAGE THAT PREVENTS ONE HAND ON HANDLE BAR OR OBSTRUCTS VIEW
- 12823 FAIL TO YIELD RIGHT OF WAY TO PEDESTRIAN
- 12824 OPERATE BY PERSON LESS THAN 16 YRS OLD / PERMIT UNDERAGE OPERATOR
- 12825 OPERATE ON HIGHWAY WITH SPEED LIMIT ABOVE 30 MPH
- 12826 OPERATE IN EXCESS OF 15 MPH
- 12827a OPERATE ON SIDEWALK
- 12829b FAIL TO DISPLAY MANUFACTURER LABEL WITH MAX SPEED/# OF RIDERS/MOTOR WATT (EFFECTIVE 06/01/2022)
- 12831 CLINGING TO VEHICLE
- 12841 FAIL TO USE BICYCLE LANE (IF PRESENT) OR RIGHT SHOULDER
- 12842 FAIL TO RIDE SINGLE FILE
- 12843 FAIL TO STOP WHEN ENTERING ROADWAY FROM PRIVATE ROAD, DRIVEWAY, ALLEY, OR CURB
- 12851 MUST HAVE WHITE FRONT / RED REAR LIGHTS ½ HOUR AFTER SUNSET TO ½ HOUR BEFORE SUNRISE
- 12852 FAIL TO HAVE AUDIBLE SIGNAL DEVICE (BELL/HORN)
- 12853 FAIL TO HAVE BRAKE – CAPABLE OF CONTROLLED STOP
- 12861 RIDERS 16-17 YEARS OLD MUST WEAR HELMET
- 12871 LEAVE SCENE OF ACCIDENT W/ PHYSICAL INJURY (18 YEARS OLD OR OLDER)
- 12881 LEAVE SCNE OF ACCIDENT W/ SERIOUS PHYSICAL INJURY (18 YEARS OLD OR OLDER)
- 1289 DWI LAWS PERTAINING TO SCOOTERS
