**Item #1 Approval of Minutes May 21, 2018**  
**Member Gorman motioned to approve the minutes of the May 21, 2018 meeting. This motion was seconded by Chairwoman Nieminen and was carried by the Board with a vote of 2-0.**

**Item #2 335 Columbus Avenue New Monument Sign**  
Mr. Nick Contrata of Sign Design, representing Spine & Joint Group, presented an application for a monument sign. The monument sign will be located in the same location as the previous monument sign. The monument sign will be double sided in blue background with white lettering. The posts will be 4 by 4 pressure treated wood. The sign measures 24 inches by 24 inches with three 6 inch panels under the main sign. The main sign has “335” in 3.5 inch numbers, “Spine & Joint Group” in 2.4 inch letters and “Chiropractic Care” in 1.5 inch letters. The first panel “Pain Management” is 2.2 lettering, the second panel “Acupuncture” 2.2 lettering and the third panel “Physical Therapy” 2.2 lettering.

**Chairwoman Nieminen made a motion to approve the application as presented for “Spine & Joint Group” with a variance for the additional description of services. This motion was seconded by Member Gorman and was unanimously carried by the board with a vote of 2-0.**

**Item #3 6 Cameron Place New Awnings/Arm Sign**  
Mr. Michael Santoliquido of San Signs and Awnings representing “Danielle David Salon” presented one arm sign, and one awning sign. The arm sign measures 36 inches round in burgundy background and gold leaf letters. The letter size for “Danielle David Salon” is 4 inches. This arm sign will be placed over

the entrance door. The awning sign measures 108 inches with a projection of 30 inches. "Danielle David Salon" will be 4 inch letters. The color of the awning is burgundy with gold leaf letters. There was discussion regarding the size of the arm sign and possibility of reducing it to 32 inches round. There was also discussion regarding the 30 inch projection of the awning and if that could possibly be reduced to 24 inches. Mr. Santoliquido said that he had no problem reducing the size of the arm sign and the projection of the awning.

**Member Gorman made a motion to approve the application for "Danielle David Salon" upon submitting a revised rendering of the changes. The arm sign will be 32 inches round and the awning will have a 24 inch projection. A variance was granted for the awning because it exceeded the maximum projection of 18 inches. This motion was seconded by Chairwoman Nieminen and was unanimously carried by the board with a vote of 2-0.**

The next meeting will be held on Monday, July 16, 2018 at 2:30pm.

There being no further comments from the public or business before the Board, upon motion duly made, seconded and unanimously carried, the meeting was adjourned at 2:55 pm.
