- 1) Public hearing to consider a proposed local law prohibiting the sale of electronic nicotine delivery products in the Village of Tuckahoe

- 6) Setting a public hearing for September 14, 2020 to consider a proposed local law to allow the adoption of a budget for the fiscal year commencing June 1, 2021 that requires a real property tax levy in excess of the amount otherwise prescribed in GML section 3-c

- 7) Authorizing 21 Columbus LLC to make improvements on Village property as required by their Planning and Zoning Board approvals; such improvements shall also consist of drop curbing work at the proposed crosswalk, new tree replacement, installation and replacement of a street lamp
- 8) Authorizing the cancellation of the August 10<sup>th</sup> Board of Trustee Meeting
- 9) Authorizing the approval of vouchers in the amount of \$708,863.12
