

PURCHASE AGREEMENT

The Village of Tuckahoe ("Tuckahoe") agrees to purchase for the sum of One Thousand Two Hundred and no/100 (\$1,200.00) Dollars from the Village of Rye Brook ("Rye Brook") a surplus motor vehicle, formerly used by Rye Brook, that is a 2004 Jeep Grand Cherokee bearing vehicle identification number 1J4GW48N74C4299963 ("Jeep Grand Cherokee"). Tuckahoe agrees and acknowledges that it takes title to the Jeep Grand Cherokee "As Is" and without any representations or warranties of any kind by Rye Brook, any and all of which are expressly disclaimed. Tuckahoe hereby covenants and agrees not to file any action, complaint, claim or proceeding, administrative or judicial, against Rye Brook in any court of law, admiralty or equity or before any administrative agency or arbitrator, seeking damages or other remedies, with respect to the Jeep Grand Cherokee.

Tuckahoe, for and in consideration of the sale of the Jeep Grand Cherokee, by this instrument does hereby forever release and discharge Rye Brook, its officials, directors, officers, administrators, employees, volunteers, agents, representatives and members of the Village Board (collectively "Releasees") from any and all actions, claims, proceedings, suits or demands in law, equity, contract and/or tort, whether known or unknown, unforeseen or unanticipated that Tuckahoe now has or may in the future have for, upon or by reason of the Jeep Grand Cherokee, including but not limited to injury, death or property damage, resulting from any cause whatsoever, including, but not limited to negligent or other acts of the Releasees and the condition of the Jeep Grand Cherokee upon receipt. Tuckahoe also agrees that it will not make any claim whatsoever against, sue or attach the property of any Releasee in connection with any of the matters covered by the foregoing Release.

Tuckahoe has carefully read this Agreement and fully understands its contents. Tuckahoe and Rye Brook acknowledge that this Agreement represents the full, final, and complete agreement relating to the Jeep Grand Cherokee, so that this Agreement supersedes all prior agreements or representations, written or oral, if any, between the parties relating to the Jeep Grand Cherokee. Tuckahoe is aware that this is a Release of Liability and a contract between them and Rye Brook, and they execute the same of their respective own free wills. The undersigned representative of Tuckahoe hereby represents and warrants that the undersigned is an officer, director, or agent of Tuckahoe with full legal rights, power and authority to enter into this Agreement on behalf of Tuckahoe and to bind Tuckahoe with respect to the obligations enforceable against Tuckahoe in accordance with its terms.


WHEREFORE, the parties have executed this AGREEMENT.
