Trustee Quigley called the meeting to order at 8:00 P.M.

Trustee Luisi read the following statement:

I would like to thank everyone who took the time to vote in the March election. To my family who never stop paying tribute to the true meaning of "family". To my dear friends who have been there with me thru "thick and thin". To my fellow colleagues in local and county government, for your unwavering support and sound advice. I am humbled and so grateful for all the assistance I received during the weeks of campaigning. I truly appreciate the public trust that has been given to me as a result of your efforts.

The success of Tuckahoe government will be well founded by my fellow board members, Mayor Steve Ecklond, Deputy Mayor Tom Giordano, Trustee's Janette Hayes and Steve Quigley. They are ready, willing and able to keep Tuckahoe vibrant and attractive to both residents and business. I am excited to once again be working side by side with them...confident in knowing that our exchange of ideas will make Tuckahoe a better place for everyone to live, work and play. I look forward to and will work hard to be a part of, what will continue to move this village in the right direction. Thank you.
