

# HOW TO READ YOUR CON EDISON BILL

## #1 ESCO ELECTRICITY SUPPLY CHARGES:

The total amount charged for the electricity through the Westchester Power CCA.

## #2 CON EDISON ELECTRICITY CHARGES:

The total amount charged by the utility (ConEd) for the use of its lines to deliver electricity to your premise. This is a delivery charge.

## #3 YOUR ELECTRICITY CHARGES (YOUR TOTAL DELIVERY CHARGES):

This is the breakdown and total amount of delivery charges from the suppliers utility, including taxes and surcharges. This is called "electricity charges" on page one, but is better known as "delivery charges."

## #4 YOUR SUPPLY CHARGES:

This is called "ESCO electricity supply charges" on the first page and is further described in the section titled "Your electricity supply detail" on the following page (#7).

## #5 GRAPH:

This is a chart showing your monthly electricity usage over the past year. For your current billing cycle, it compares your energy usage for the month with last year's energy usage for that same month.

## #6 YOUR ELECTRICITY SUPPLIER:

This is the energy supplier selected by our program, Westchester Power, CCA, a program of nonprofit Sustainable Westchester.

## #7 SUPPLY COST (CENTS PER KWH):

This is the total cost of your electricity supply, which includes the fixed rate in cents per kWh and the taxes required by New York State.

## #8 SUPPLY (#1) + DELIVERY (#2) CHARGES:

Prior to this supply and delivery was shown together in one total. The charge to Westchester Power is now broken out. It does not mean you are getting charged twice nor does it mean you are getting a charge you did not have in the past.
