- 2. AFTER DENIAL LETTER, SUBMIT APPROPRIATE FEE ALONG WITH 10 SETS OF ARCHITECTUAL DRAWINGS, COPIES OF DENIAL LETTER AND COPIES OF PLANNING BOARD APPLICATION.
- 3. AN OWNER/REPRESENTATIVE MUST APPEAR AT THE BOARD MEETINGTO ANSWER QUESTIONS OR APPLICATION WILL NOT BE ADDRESSED.
- 4. LEGAL NOTICE TO APPEAR IN **THE EASTCHESTER REVIEW** 5 DAYS PRIOR TO THE MEETING.
- 5. AFTER BOARD APPROVAL APPLICANT MUST RETURN TO THE BUILDING DEPARTMENT AND OBTAIN BUILDING PERMIT.
