SUEZ Water Westchester reserves the right, at its sole and absolute discretion and at any time, to change any or all of the rebate program policy, or to cancel the rebate program without prior notice. Applicant must submit a copy of the sales receipt with the application. Customer shall be responsible for all taxes that may be imposed with respect to the rebate offer.
